2xAvro 504Ks were deld to the Chilean Army in May 1919; a further 7 in 1920 and 3 in 1925. No identities known. 2 were also deld to the Chilean Navy in 10.18 (with G-EAMO/EANE deld in 8.21.

Greece

4 Avro 504Ns (180hp Lynx) were handed over to Greek Ministry of Marine 6.25 at Woodford; painted in military markings without serials. It has also been reported that 24 Avro 504N/Os were deld late 20s, followed by another 12 in 1931 and 10 in 1935.

Per John Mylonas; Initially Royal Hellenic Naval Air Service who was oriented and followed the British Naval Air service system, aircraft ordered Six Avro 504N/Os which were supplied in 1925 to Works Order 7787 for training schools at Tatoi and Phaleron Bay. Although the S/ns or C/ns of these six aircraft are not known it seems that the aircraft received the Code Nos. Ea1 to Ea6. According to <http://britishaviation-ftp.com/avro504n.html> and "Avro Aircraft Since 1908" by A.J. Jackson as well as "The Avro 504 Historic Military Aircraft No. 8" Flight magazine 16Jul54.

These were followed by 12 Avro 504K from British stocks Ex H3048, H3049, H3052 - H3055, H9687, H9716, H9725, H9730, H9734, H9746, according to <http://britishaviation-ftp.com/avro504k.html> and British Military Aircraft Serials, 1878 - 1987, Bruce Robertson.

Further than the above an order of at least 15 aircraft was placed to the Phaliron Aircraft Factory (Ergostasio Aeroplanon Phalirou) the Greek State Aircraft Factory known as KEA while 10 were reconditioned, to be followed by 24 more that were delivered by 1934 these been mixed N & O machines. according the Blackburn archives and <http://britishaviation-ftp.com/avro504n.html>

Judging by existing photos and pilot's log books and the Hellenic AF archives the total number eventually built goes as high as 139, when the production stopped in 1935 to divert to the more modern type Avro 626.

The aircraft receive as mentioned initially Serials EaXX and so on, only to be change to EXX and finally to NAYXX

An Avro (504K?) dd 1.20 to TK Wong Ltd, Kuala Lumpur crashed on its first post-assembly flight at Kuala Lumpur Racecourse 26.2.20 when it spun in on a climbing turn; pilot Capt Leonard James Pugh killed, Lt HFO Farrell injured.

Norway

2 Avro 504 (100hp Sunbeam Dyak) deld Norwegian Army AF at Kjeller 2.11.20 and given serials 103 & 105. 105 soc Kjeller 29.10.23. #103 preserved at Bodo. #103 has quoted identity of B5405 but erroneous.

Peru

7 or 8 Avro 504Ks were sold to Peru via ADC in 1921/22 including E372, E391, E395, E399, E6766 & H1908. A number of Avro 504Rs were sold to Peru in mid 1920s.

Spain

At least 4 Avro 504Ks were purchased from ADC, Croydon by the Spanish Royal Naval Air Service 6/25. They appeared to be handed over without markings.

Two were operated by PO Flygkompani, Sweden [1919/20] under contract with Lt Col GLP Henderson.
