Sold for £12,000 and regd (CofR 1914) 13.3.29 to Ellyou Goldfields Development Corporation Ltd, London EC4; based Wau & Lae, New Guinea. Regn cld 10.29 as sold abroad. Regd **VH-ULK** (CofR 309) 5.8.29 to same owner. Struck trees during forced landing at 8,000 ft in thick cloud over the Kupar Range en route Salamaua to Wau, NG 31.5.30; pilot George I Thomson/mechanic McMurtrie rescued 5.6.30. Regn cld 30.6.30.

HP35/1 ex **J9949** Regd **G-ABIP** (CofR 3008) 2.2.31 to The Air Council, London SW1; intended for use by Imperial Airways, Croydon. No CofA issued and regn believed not used. Regn cld 8.32 as wfu. Returned to RAF as **J9949**.

The known military history of J9949 seems inconsistent with the above. J9949 is recorded as a Clive Mk.II c/n HP35/2 which ff 22.3.30 and was flown out to India 10.5.30 for use by Heavy Transport Flight, later Bomber Transport Flight. It was destroyed in a hangar fire at Lahore 31.3.33.
